



This End User License Agreement (“EULA”) between you (the Licensee) and July Type governs the use of the Free Trial font software and fonts provided by July Type. By downloading or using the Free Trial font software, you acknowledge that you have read, understood, and agreed to be bound by the terms and conditions of this EULA.

### **1. Ownership**

- 1.1 The digital files downloaded to your computer constitute font software, acknowledged by the Licensee as the property of July Type, with its structure, organization, and code deemed valuable trade secrets.
- 1.2 The intellectual property within the font software’s design is owned by July Type.
- 1.3 The Licensee acquires a non-exclusive license, conferring specific rights to use the font software, without constituting a sale of the font software, its design, or any portion thereof.

### **2. General lawful use of product**

- 2.1 Acceptance of this EULA grants a license to install the Free Trial font software on an unlimited number of computers owned by the Licensee.
- 2.2 The EULA permits the use of Trial Fonts solely for internal preview and evaluation purposes.
- 2.3 The Licensee is not authorized to sublicense, sell, lend, or lease the font software.
- 2.4 Modification, conversion, or renaming of the original font software is prohibited.
- 2.5 Accessing the original font software in an editing software to reveal its structure, organization, or code is not allowed.
- 2.6 The original font software file cannot be used to create derivative or modified products or designs, including characters for unrepresented alphabets and languages.

### **3. Embedding and prohibited use of Trial Fonts**

- 3.1 Embedding Restrictions: Unauthorized embedding of the font software in publicly accessible documents, applications, websites, or video streams is prohibited. Trial Fonts are strictly for internal preview and evaluation, not for public embedding.
- 3.2 Secured Read-Only Mode: Embedding in a secured read-only mode is allowed, subject to restrictions. Measures must be taken to secure embedded documents against unauthorized use. The prohibition on using Trial Fonts in the final output applies, as outlined in Section 4.

### **4. Prohibited use of trial fonts**

- 4.1 Final Output Restriction: Trial Fonts are strictly for internal preview and evaluation. Usage in the final output of any work, whether for commercial or non-commercial purposes, is prohibited.
- 4.2 No Publication or Dissemination: Materials created using Trial Fonts, including printed materials, digital content, online publications, or any other output, shall not be published, disseminated, or made available to the public.
- 4.3 Scope of Restriction: The prohibition on using Trial Fonts in the final output extends to all project types, irrespective of purpose or audience. Trial Fonts are limited to internal evaluation and preview only.
- 4.4 Termination Clause: Violation may lead to immediate license termination, with the Licensee subject to charges equivalent to the cost of a license for actual usage, on a per-infringement basis, without discounts.

### **5. General usage**

- 5.1 Font software may not be installed or used on a server accessible via the Internet or external network system.
- 5.2 Additional copies of the font software may be made exclusively for data backup purposes

### **6. Limited warranty and liability**

- 6.1 Limited Warranty: July Type provides no warranties, express or implied, on Free Trial files.
- 6.2 Intellectual Property Warranty: July Type warrants having the necessary rights for this agreement and ensures that the font software does not breach third-party intellectual property rights.
- 6.3 Disclaimer of Warranties: Excludes warranties of fitness for a particular purpose and merchantability.
- 6.4 Limitation of Liability: In no event will July Type be liable for consequential, indirect, or incidental damages.
